

## NOTES TO POTENTIAL CONTRIBUTORS

### MANUSCRIPTS MUST BE SUBMITTED:

- in English,
- both printed and electronic versions,
- in Microsoft-Office-Word (\*.docx or \*.doc) format,
- page size: A4,
- font parameters: Times New Roman, size for the main body: 12 pt., for footnotes: 10 pt.,
- footnotes should be provided at the bottom of the page; the references – at the end of the paper,
- spacing: 1.3, for the footnotes: 1, first line: 0.8 cm.

The Author is obliged to guarantee the compliance of the manuscript with the scope of content-based priorities of the periodical, thus providing the final copyright version,

### THE LENGTH:

The manuscript should not exceed 8000 words.

### THE TITLE:

- should outline the general scope of the paper not exceeding 8 words,
- uppercase,
- font-size: 12

### AUTHORS' DATA:

- first name(s), last name(s), and CV(s),
- full name and postal address of each author's workplace, organization,
- position, rank, academic degree,
- e-mail and phone number,
- surnames and the initials of authors' names should be in uppercase.

### ABSTRACT:

- should not exceed 200 words,
- should be informative, avoiding general words and phrases,
- should outline the research and results,

- should reflect the main content of the paper, taking into consideration the following viewpoints: *subject, purpose, research results, and conclusions*,
- should not duplicate the information in the title,
- should provide a good perspective on the final message of the article.

## INTRODUCTION

- should reflect the contribution to the scope of philosophy and methodology of science,
- should reflect the current concerns in the area,
- should specify the research objectives.

## CONCLUSIONS

- should be clearly formulated and formatted.

## KEYWORDS:

- up to 10,
- separated with commas.

## REFERENCES

- The manuscript should be submitted using the APA citation system. For instance: (Soros, 2001, p. 10) (Toulmin, 1958, pp. 56-57) (Hilbert & Bernays, 1934).

**The Latin transliteration of all the non-Latin references should be included as well. For instance:**

- Брутян, Г. А. (1992). Очерк теории аргументации. Ереван: Изд-во АН Армении.
- Brutian, G. A. (1992). *Ocherk teorii argumentatsii* (Outline of Argumentation Theory, in Russian). Yerevan: NAS RA Publication.

### **For a book by a single author:**

Toulmin, S. E. (1958). *The Uses of Argument* (updated ed., 2003; reprint, 2006). New York: Cambridge University Press.

### **For a book by two or more authors:**

Calfee, R. C., & Valencia, R. R. (1991). *APA guide to preparing manuscripts for journal publication*. Washington: American Psychological Association.

**For a book by an editor:**

Ayer, A. J. (Ed.). (1959). *Logical Positivism*. Glencoe, Illinois: The Free Press.

**For an article in a journal:**

- Jacoby, W. G. (1994). Public attitudes toward government spending. *American Journal of Political Science*, XXXVIII (2), 336-361.
- Djidjian, R. Z. (2016). Paradoxes of Human Cognition. *Wisdom*, 7(2), 49-58.

**For a book section:**

O' Neil, J. M., & Egan, J. (1992). Men's and women's gender role journeys: A metaphor for healing, transition, and transformation. In B. R. Wainrib (Ed.), *Gender issues across the life cycle* (pp. 107-123). New York: Springer.

**If various works of the same author published in the same year are cited, it is necessary to apply to a letter differentiation method, i.e., a, b, c, etc.** *E.g.*, (Hovhannisyan, 2006a; Hovhannisyan, 2006b; Hovhannisyan, 2006c).

**For a website publication:**

Texts of articles submitted on a website usually vary from their printed versions. That is why it is necessary to indicate the appropriate electronic address when citing the website versions. Moreover, the citation of the printed version is not accepted.

**GRAPHS AND DIAGRAMS**

If the manuscript contains nonalphabetic characters (e.g. logical formulae, diagrams), then:

- the PDF version of the text should be attached for verification,
- all the images (diagrams, line drawings and/or photographic images) should be numbered sequentially with Arabic numerals and submitted in electronic form,
- photo images should be of high quality,

- all the images should be attached as separate files,
- diagrams, line drawings, and charts should be submitted in EXCEL or EPS format.

### **VARIOUS KIND OF MANUSCRIPT FORMATTING PECULIARITIES**

#### ***Publication of Archive Materials and Translation Sources***

- A complete description of archive or publication material, i.e. the original text sources, should be included in the manuscript.
- A brief (1-3-page-long, approximately 4000 characters) prologue under Publication Prologue may precede the publication. Long prologues are considered articles, so they should be written under separate titles.
- If the publishing source contains references, they should be presented as a part of the body text – each numbered sequentially and preceding the body text source.
- A publisher or translator may present references about the publishing source at the end of the body text.
- Via references, one may present in the source text, between square brackets, word translations, explanations of acronyms, abbreviations, etc.,
- Choosing up to 40.000 character-long sources for the materials submitted is advisable. In the case of an extensive source, it is necessary to shorten (select) to prepare the periodical material.
- Translations and archive sources should appear with comprehensive comments and complete referencing. Otherwise, they may not be considered scientific publications and cannot be published.

#### ***Essays of various symposiums and scientific events***

- Information about the symposium should be included in the essay.
- Symposium members' names, surnames, workplaces, and countries should be mentioned in brackets, and in the case of international symposiums, the city's name should also be included.
- Essays should not coincide with the symposium projects or their final documents.

#### ***Reviews and bibliographical essays***

- A review should be 5 to 10 pages (10.000-20.000 characters).
- Final information, such as the publication's name and the book's number of pages,

should precede the body text.

- References are not included in the review.

***Argumentative notes, essays, records***

Materials written in freestyle, beyond the requirements for scientific papers, are accepted for publication. Such papers may not be involved in reports about scientific works.

***Attention!*** All authors are responsible for the viewpoints introduced in their papers, which may not always coincide with those of the Editorial Board. All articles pass single-blind review and are checked by <https://www.quetext.com>, <https://text.ru/antiplagiat>, <https://www.antiplagiat.ru/> systems.
